This Privacy Notice concerns the processing of your personal data in the context of the **Competition** and for which nominations might be send and announced in March 2022.

# Personal data processed

For the purposes of the Competition the following categories personal data of the participants will be processed:

- the employees of AC3 partner NRENs and all users who are member of partner Institutions. Entrants must be 18 years or older. Entrants under 18 years of age require the permission of parent or guardian. Employees of AC3 regional Research and Education networks namely UA, WACREN, ASREN are not eligible.
- Winners of the Competition

For the Competition the following personal data regarding the participants will be processed: name, work/study affiliation, email address and Twitter handle - will be processed in order to organise the contest and select winners. In case of individual/group photo submitted – additional information about the people on the photo.

Additional data such - as address and bank account number – might be processed in order to ship the gift baskets to the winners and, if applicable, reimburse custom duties.

This processing does not involve any of special category of data (the process involves the basic contact information and information relating to photo submitted during the Competition and in case of winners: address and bank account number).

#### Purposes of data processing

The personal data will be processed for the verification against eligibility criteria and then selection and announcement of the winners of the Competition as well as promotion of AC3 and its activities.

# Legal basis for processing

For the purposes of processing related to the Competition we process personal data received directly from and about the person submitting a picture for the Competition. This processing is based on the **legitimate interest** consisting in promotion of AC3 by creating the image database which can be re-used for the promotion of the project and project-related activities, what is not overridden by the interests or fundamental rights and freedoms of the nominating (data subject).

## Your rights
